all questions easily, and needed no probing at all. Sometimes it was even difficult to stop his flood of words.

Respondent is the tense and nervous type, and seemed a bit tired during a part of the interview. He corfessed that for the past five months he has not been sleeping more than five hours a night.

He is not the typical peasant type, as, for example, subject 79-M. But, he is a typical example of those peasants who, under the pressure of forced collectivization, have been compelled to seek employment in the industries.

Subject is of medium height, broad shouldered, muscular, good-looking, a bit untidy in his appearance, With only six years of grade school, he is fairly intelligent, keenly interested in politics. Took an active part in the Hungarian Peasant Union and the Peasant Party. He answered
