### NAGY AND MALETER TRIAL PELIEVED PENDING

SOURCE VIENNA: Confidential.

DATE OF OBSERVATION: End-January 1958.

ENGLISH SUMMARY: According to current opinion in BUDAPEST, the political show-trials against Imre NAGY and Pal MALETER will start in the near future. This view became general after the recent changes within the Covernment.

It is also said that preparations are being made for the trial of BIBO.

EVALUATION COMMENT: This report echoes current views in BUDAPEST which cannot be taken as new evidence on the probability of a trial of Imre NAGY and his associates.

It is obvious from the wording of the report that these views should be regarded much more as a comment on the recent Government reshuffle and are characteristic of the people's mood in BUDAPEST.

The arrest of an employee of the French Legation in BUDAPEST is UNCONFIRMED here.

## NAGY AND MALETER TRIALS BELIEVED PENDING

DATE OF OBSERVATION: End-January 1958.

EVALUATION COMMENT: This report echoes current views in BUDAPEST which cannot be taken as new evidence on the probability of a trial of Imre NAGY and his associates.

It is obvious from the wording of the report that these views should be regarded much more as a comment on the recent Government reshuffle and are characteristic of the people's mood in BUDAPEST.

The arrest of an employee of the Franch Legation in BUDAPEST is UNCONFIRMED here.

According to current opinion in BUDAPEST the trial of Imre NAGY, former prime minister, will begin in the near future. It is also the general opinion that the delay in beginning the trial is attributable to KADAR. The reason for this postponement might be that, during the revolution, before KADAR vanished from the parliament, he agreed in many points with Imre NAGY and it was feared that, in case of a trial, these areas of agreement would be revealed by NAGY. According to BUDAPEST opinion, MUNNICH considered a merciles, brutal terrorist, who is expected to increase political control and use of force, will initiate the trial against NAGY soon.

It is believed also that the trial of Pal MALETER, will be held under MUNNICH's premiership.

Apparently, proceedings against Istvan BIBO are also about to begin. Several recent arrests seem to confirm this view. One of the Hungarian employees of the French legation, among others, was arrested.
